ELECTION NOTICE

Notice is hereby given that the City of Blanding will hold a municipal election this fall to elect one Mayoral seat for a four-year term (2022-2026), two City Council seats with four-year terms (2022-2026), and one City Council seat to complete the remaining two years of a current four-year term (2020-2024).

City Council candidates must declare if they are running for one of the two seats with the full four-year terms (2022-2026) OR running to complete the remaining two years of the term for the current four-year seat (2020-2024).

Persons desiring to be candidates for the 2021 City of Blanding Municipal Election must file a declaration of candidacy form or nomination petition between June 1, 2021 and June 7, 2021 at the City Office, 50 W 100 S, Blanding, Utah weekdays between the hours of 7:30am - 5:30pm Monday - Thursday and 7:30am and 5:00pm Friday.

Candidates must meet the following qualifications: 1.) Be a United States citizen; 2.) Be a registered voter of the City; 3.) Be a resident of Blanding City for at least 365 consecutive days immediately preceding the date of the election; and 4.) Not be a convicted felon, unless their right to hold elective office has been restored.

The primary election, if necessary, will be held on Tuesday, August 10, 2021 and the municipal election will be held Tuesday, November 2, 2021.
